- 1. BY PLACING AN ORDER FOR A SERVICE OF SORSHA SEVEN SINGER EITHER VERBALLY, ONLINE OR VIA EMAIL, IT IS DEEMED THAT THE CUSTOMER (YOU) HAS READ, UNDERSTOOD, FULLY AGREED TO AND IS BOUND BY ALL CONTRACTS AND TERMS AND CONDITIONS
- 2. UNTIL THE DEPOSIT IS PAID THE CUSTOMER HAS THE RIGHT TO CANCEL THE SERVICES OF SORSHA SEVEN SINGER AT ANY TIME.
- 3. ONCE THE PRICE HAS BEEN AGREED, THE CUSTOMER MUST PAY A DEPOSIT TO GUARANTEE THEIR EVENT DATE AND CONFIRMATION. IF THE DEPOSIT IS NOT PAID, SORSHA SEVEN SINGER HAS THE RIGHT TO TERMINATE ANY CONTRACT AT THEIR WILL.
